Category 1: Any baked dessert using any dairy product – Each product must have two copies of the recipe attached

Category 2: Any food item using Red Star Yeast – No Bread Machine Products-Each product must have two copies of the recipe attached, one must have empty yeast packet attached as well.

Youth Contest Ages 5-12 - Any dessert or food item fitting Category 1 or 2

2:45 Youth Judging

Contest Rules:

- 1) Open to any individual 8-12 years of age who is a Jefferson County resident.
- 2) Entry must be any baked dessert, made from **scratch** using any dairy product (examples below).
- 3) Entry must be submitted as a plate of six on a doily covered cardboard or paper plate.
- 4) Complete recipe listing the ingredients, preparation instructions and recipe author must be submitted with the entry, printed on one side of the page. Please submit two copies of the recipe, one without your name for the judges and one with your name for the registration. No name brands listed in recipe. Yeast packet must be attached for Category 2 entries
- 5) Entry must be made by the participant.
- 6) Upon submission, all entries become the property of the fair.

Teen Contest Ages 13-17 – Any dessert or food item fitting Category 1 or 2
2:45 pm Teen Registration
Teen judging to follow Youth Judging

Contest Rules:

- 1) Open to any individual 13-17 years of age who is a Jefferson County resident.
- 2) Entry must be any baked dessert, made from **scratch** using any dairy product (examples below).
- 3) Entry must be submitted on disposable plate, aluminum pan or aluminum covered cardboard.
- 4) Complete recipe listing the ingredients, preparation instructions and recipe author must be submitted with the entry, printed on one side of the page. Please submit two copies of the recipe, one without your name for the judges and one with your name for the registration. No name brands listed in recipe. Yeast packet must be attached for Category 2 entries
- 5) Entry must be made by the participant.
- 6) Upon submission, all entries become the property of the fair.

Adult Contest Ages 18 and up – Any dessert or food item fitting Category 1 or 2
3:00 pm Adult Registration
Adult judging to follow Teen Judging

Contest Rules:

- 1) Open to any individual 18 years of age or older who is a Jefferson County resident.
- 2) Entry must be any baked dessert, made from **scratch** using any dairy product (examples below).
- 3) Entry must be submitted on disposable plate, aluminum pan or aluminum covered cardboard.
- 4) Complete recipe listing the ingredients, preparation instructions and recipe author must be submitted with the entry, printed on one side of the page. Please submit two copies of the recipe, one without your name for the judges and one with your name for the registration. No name brands listed in recipe. Yeast packet must be attached for Category 2 entries
- 5) Entry must be made by the participant.
- 6) Upon submission, all entries become the property of the fair.

Judging for all contests will be based on the following criteria:

a. Flavor	30 points
b. Overall Appearance	25 points
c. Moistness and Crumb Texture	20 points
d. Consistency (size and shape)	15 points
e. Creativity (appearance, ingredients, etc	10 points
	100 points

**Examples of dairy products are milk, cheese, yogurt, sour cream, whipping cream etc.
No artificial dairy products allowed.**
